 - Both need formal approval by both PCs to enable CPC to proceed

 - PC July meetings
 - Due to late reformation of CPC the 1st Action plan will actually cover the period July 2022 to December 2023
 - 1st part of that process was Public Consultation Event
 - 18 Month Action Plan 4 parts
 - Volunteer & Professional Work Program
 - Proposed Event Program
 - Budget and Cash Flow
 - Long term Project Plan
 - Volunteer & Professional Work Program
 - Volunteer Program
 - o Relocating and securing the Benches as per the 2021 RoSPA report
 - o Prestaining/ Painting of the benches.
 - Widening, and leveling of the Highgate Lane Entrance Pathway to make more accessible for pushchairs, wheelchairs, mobility scooters, etc.
 - New Pathway entrance from Owmby pedestrian gate
 - Similar to the Highgate Lane Entrance

- Volunteers needed
- Proposed Event Program
 - Annual Scare Crow Festival x 2 July 22 and July 23
 - Family Craft Events July/Aug 22 & 23 on the park
 - Boot Fair under consideration
 - Sunflower Competition 23
 - Summer Fete September 22 & 23
 - Pub Quiz and Race Nights to be held in the Pub over the winter evenings
 - o Early consultation with new owners of pub
 - Christmas Raffle 22 & 23
 - Christmas Craft market November 22 & 23
 - Advent Calendar Window Dressing December 22 & 23
 - Christmas Jumper Walk December 222 & 23
 - Christmas Raffle December 22 & 23
- Finances
 - Approx. £7500 in the bank
 - Need to ringfence £2000 to put on above events
 - Nominally £5500 to spend
 - Above Maintenance costs have to come out of remaining cash budget.
- Major Projects
 - All weather walkway around the perimeter of the park.
 - o 100% of people who attended consultation event wanted this
 - All weather Walkway within Wildlife area linking to perimeter walkway
 - 75% of residents who attended consultation event wanted this
 - Boules court.
 - Purchase of our own Marquee(s)
 - Grant funding will be required for -
 - Children's Playground
 - 88% of residents who attended consultation event wanted more play equipment
 - Swings circa £23,000
 - Fencing perimeter of playground £7500
 - Additional/replacements football goals
 - Provision of metered services circa £5500
 - Electrical Power ~£2500
 - Water ~£3000
 - Storage/Hub
- Grants
 - ~8000 charitable organizations in the UK that offer grants
 - For a wide variety of projects including -
 - Supporting Local Communities and their Facilities
 - We then need to ascertain

- o Where (geographically) an organization might provide funding
- When they might provide funding
- o Who can make the application on behalf of the PC's
- Lots of hoops we have to 'jump' through
 - o Who we are
 - o Can we deliver the project
 - o How are our fincances managed
 - o Can we demonstrate the need for funding
 - Who and how many will benefit, in what way
