Lincolnshire are currently trying to locate all blue light services together at Nettleham. Highways have £5million for potholes from central government. Cllr Strange reported that east west link is working well in Lincoln. It won't be fully operative until the bus station is operating. Progress on the bypass keeps being put back due to finds of archeological interest. Park and ride service from Waitrose into Lincoln is working well. Elections will be held on May 4th. Cllr Strange will be standing again.

Cllr Summers asked the clerk to report that despite the squeeze on funding WLDCs approach to commercialism and regeneration of the district has brought in £6.035 million of additional funding during the last 12 months.
